Sub:- Data base of Group 'B' officers of CCAS-reg.


Reference is invited to this office O.M. of even No. 201 dated 10th June 2016 & 15th July, 2016 on the above cited subject. The 'Integrated Central Civil Accounts Organization' application (Group 'B' Database) is under implementation by this office. The application provides for capturing personal information, employment history and training details and details of APARs. of Group 'B' officers to address the need of effective cadre management.

2. It is reiterated that the responsibility of initial data entry lies with individual AAOs/AOs/Sr.AOs which will be verified by the concerned Pr. Accounts Offices of the respective Ministries/Deptt. As the server pertaining to database was under shift from Lok Nayak Bhavan to new CGA building, the data base work was kept in abeyance. **The application is now available on new URL <http://10.199.72.50/CGAGRB> in place of earlier URL <http://10.23.150.99/cgagrb>.** The Pr. AO will verify the entries made by the individual by login at Pr.AO level and will then submit the same to CGA office. The login id will remain same as issued earlier and can be accessed on nic.net connection.

3. All Pr. CCAs/CCAs/CAs may nominate an officer of the level of AAO/PAO/Sr.AO who will ensure completion of the data entry in time bound manner and the same may be informed to this office. He/She may be directed to keep in touch with the Group 'B' Section O/o CGA at phone no.2466 5362 or through e-mail groupbsec-cga@gov.in for URL address, Login ID/Password or any other problem being faced by him/her. The entire exercise has to be completed latest by 23rd December, 2016.

4. In certain cases, it has also been noticed that the individual officer has submitted the requisite information at the designated URL, however, their respective Principal Accounts Officer/PAO has not validated and submitted further to CGA office.

It is, therefore requested that Pr. CCAs/CCAs/CAs may please look into the matter personally and ensures the submission of data to this office by 23.12.2016.
